Re: 30 day notice of non-renewal of SWD-100, Dorstate SWD #1, 30-015-23728

Dear Mr. Corbitt,

Salt Water Disposal Easement No. SW-100, an easement to inject saltwater into the Dorstate SWD No. 1, expired on August 5, 2017. The State Land Office (SLO) has reviewed your renewal application and hereby provides Permian Water Solutions, LLC (Permian) notice of denial of the renewal. Numerous produced water spills at the site requiring remediation have not yet been addressed and the well is out of compliance with state regulations. In addition, Oil Conservation Division records indicate that the well is injecting at pressures in excess of the permitted amount. Please be advised that Permian must immediately cease and desist injection of saltwater into the above-referenced well.

Easement No. SW-100 will be considered terminated and your authority to access the site denied as of September 20, 2019. Permian will have 30-days from the date of this letter to contact the SLO regarding closure and full remediation of the site.

The SLO has communicated with your company, or its representatives, numerous times in attempts to resolve the remediation requirements without sufficient action to resolve them. If these issues are not fully resolved by October 20, 2019, this matter will be referred to our Office of General Counsel for further action. Also, any bonds attributable to this easement will be forfeited.
