**Plugging Report**  
**Artesia Metex Unit #67**  
**API 30-015-27195**

3/27/2020 Cleared location. Moved in rig and rigged up. Unset pump and laid down 81 ¾" rods. Pumped 20 bbls fresh water down the casing. Nippled down wellhead and installed BOP. SION

3/30/2020 Laid down 67 joints 2 7/8" tubing. Made gauge ring run to 1750'. Set CIBP at 1722'. Tagged CIBP with workstring and circulated MLF. Tested casing to 600#. Casing good. Spot 50 sx Class C cement on to of CIBP. POOH to 436' and circulated cement to surface with 50 sx. Rig down. Dig out and cut off wellhead. Filled up both strings of casing with 10 sx cement. Cement remained at surface.

3/31/2020 Installed marker, cleaned the pit, removed anchors, and cleared location.
