Devon Energy requests to pump a second remedial braden head squeeze job on the Bora Bora 13-24 Fed Com 216H after failing to achieve tie-back into the surface casing string on the primary braden head squeeze job. The job procedure as follows:

1. Rig up to 9-5/8" Casing Valve and establish injection
2. Pump 240bbls (700 sacks) of 13ppg Class C Premium Cement down 9-5/8" x 13-3/8" annulus
3. Wait on cement until 500 psi compressive strength achieved
4. Run CBL from previous TOC (1,900', confirmed via CBL) to Surface

This sundry serves as a follow up to the verbal approval from Long Vo to move forward with the second remedial braden head squeeze job.
