6/20/2020: Drill 17.5 inch surface hole to 636 ft.

Run 13.375 inch surface casing to 626 ft. Pump 40 bbls gel spacer, followed by 315 sks of 13.5 ppg lead cmt, 350 sks of 14.8 ppg tail cmt. Drop plug and displace with 90 bbls brine. 140 bbls returned to surface. Test casing to 1500 psi for 30 minutes, test failed at cement head cross over. Will Re-test after BOP installed.
