6/11/2020: Drill 12.25 inch intermediate casing to 3740 ft.

6/13/2020: Run 9.625 inch 40 lb J-55 intermediate casing to 3720 ft. Run 20 bbls chem wash, 20 bbls water, followed by 778 sks of 13.5 ppg lead cmt, 343 sks of 14.8 ppg tail cmt. Drop plug and displace with 277 bbls fresh water. 90 bbls of cmt returned to surface. Test casing to 1500 psi for 30 minutes, good test.

6/14/2020: Drill 8.75 inch second intermediate hole to 10844 ft.

6/16/2020: Ran 7.625 inch 29.7 lb P-110 second intermediate casing to 10822 ft. Pump 20 bbls chem wash, 20 bbls water, followed by 663 sks of 11.5 ppg lead cmt, 150 sks of 13.2 tail cmt. Drop plug and displace with 494 bbls of cut brine. 40 bbls of cmt returned to surface. Test casing to 2360 psi for 30 minutes, good test.
