Run 13.375 54.5 lb J-55 surface casing to 377 ft. Pump 60 bbls gel spacer, followed by 510 sks of 14.8 ppg. Drop plug and displace with 48 bbls of brine. Returned 58 bbls of cmt to surface. Test Casing to 1500 psi for 30 minutes, good test.
