Pump 40 bbls of MPE spacer, 95 bbls of mud recover, followed by 1009 sks of 14.5 ppg tail cmt. Drop plug and displace with 310 bbls of brine. 28 bbls of spacer returned back to surface. Est TOC at 6485 ft.
