ENTERPRISE NOTIFIED CHEVRON THAT THERE ARE NO IMMEDIATE PLANS TO RETURN THE LINE TO SERVICE. CHEVRON IS REQUESTING A 6 MONTH SHUT IN STATUS TO EVALUATE OPTIONS AND RESTORE PRODUCTION.
