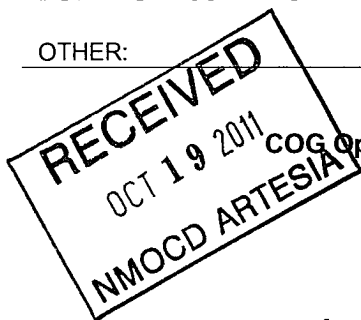

An amended plat and new Directional Plan is attached for your review.

This location move is requested due to houses being too close to the original location.

Additional Drilling Plan Changes:

COG proposes to drill a 12 1/4" hole to 825' w/ fresh water, run 9 5/8" 36# J-55 and cement to surface. Drill a 8 3/4" hole to 2298' MD and kick off and drill curve to 3048' MD. Drill a 7 7/8" lateral to new BHL @ 2775' TVD 7180' MD. Run 7180' of 7" 26# L-80 x 5 1/2" 17# L-80 casing to TD with DV/ECP Combo Tool at 2775' and isolation packers in the open hole. Set isolation packers and ECP. Open DV tool and cement from 2775' to surface.

Proposed casing and cement program: change the casing type from 5.5 to 7 x 5.5 and change the sacks of cement on the production to 300.

Also, we will downsize to a 7 7/8" hole after we land the curve.
