

Spudded 12 1/4" hole 12:00 pm 10-5-11. Drilled to 300' KB & ran 7 jts 8 5/8" 24 #/ft surface csg and cemented w/375 sx cement. Cement circulated to surface (circulate 17 sx to pit). WOC 18 hrs. Pressure test BOP and 8 5/8" surface csg to 1500 psig for 30 minutes. Held OK. Drilled 7 7/8" hole to 2740' KB. Ran 66 jts 5 1/2" 15.50 #/ft csg, set at 2722' KB. Cemented w/600 sx cement. Plug down 7:09 am 10-13-11. Circulated cement to surface (circulate 41 sx to pit).
