- 4) MIX X PUMP A 25 SX. CMT. PLUG @ 1,900'-1,700' (T/QN.).
- 5) MIX X PUMP A 25 SX. CMT. PLUG @ 1,170'-970' (T/YATES). **WOC TAG**
- 6) MIX X PUMP A 25 SX. CMT. PLUG @ 514'-314' (8-5/8" CSG.SHOE). **WOC TAG**
- 7) MIX X CIRC. TO SURF. A 10 SX. CMT. PLUG @ 63'-3'.
- 8) DIG OUT X CUT OFF WELLHEAD 3' B.G.L.; WELD STEEL PLATE ONTO CSGS. X INSTALL DRY HOLE MARKER.
