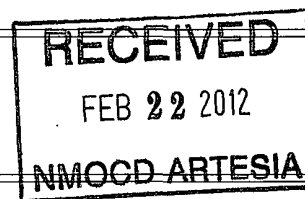

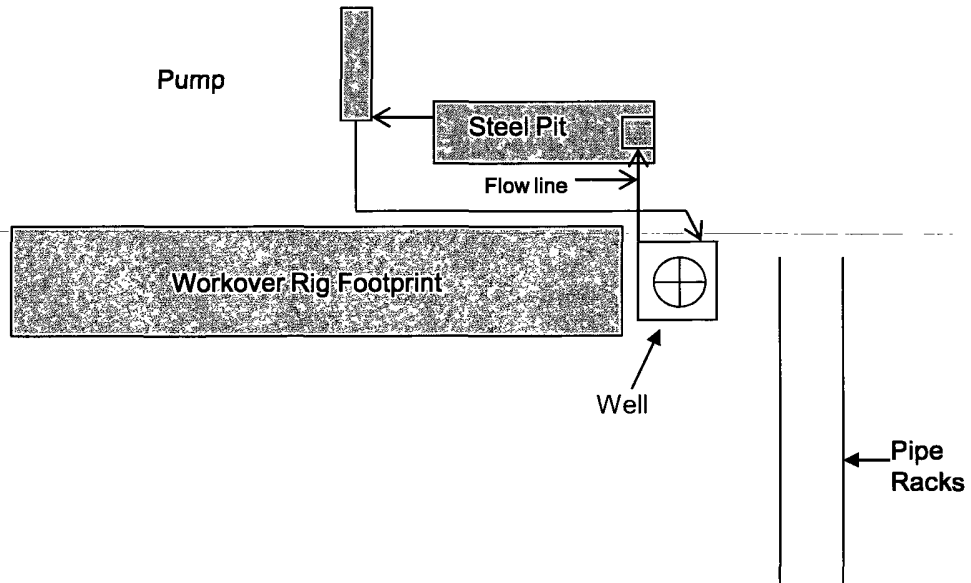

Closed Loop Operation & Maintenance Procedure

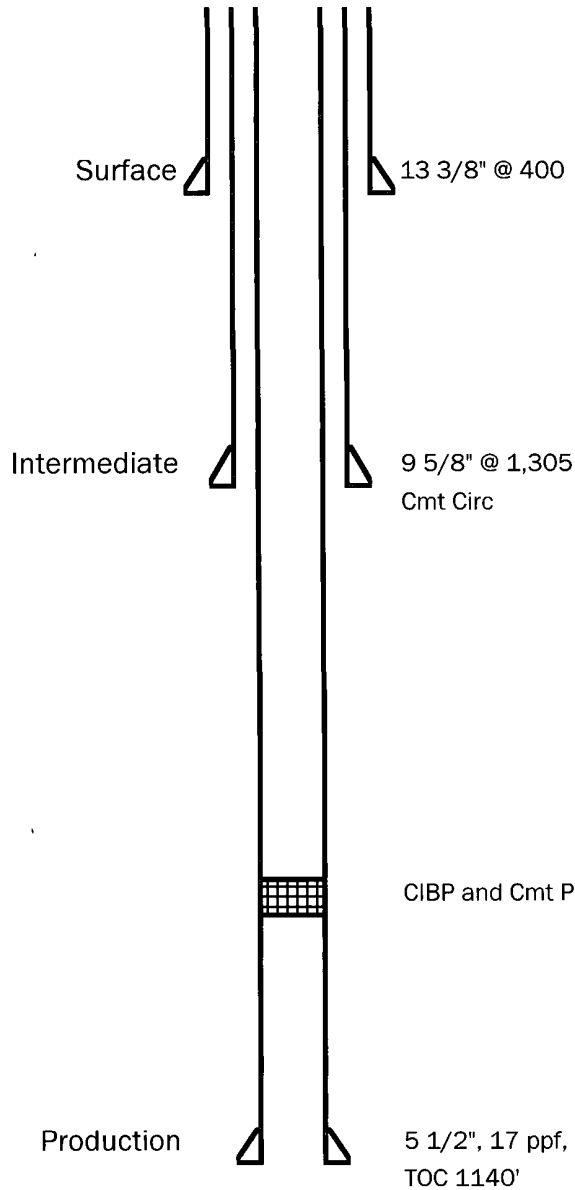
