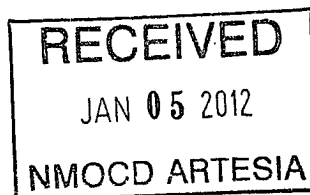

Mixed @ 14.8 #/g w/1.34 yd. Plug down @ 3:45 AM 11/24/11. Circ 150 sks cement to pit. WOC 18 hrs. Tested BOPE to 3000# & annular to 1500#. At 3:15 AM 11/25/11, tested csg to 1250 for 30 mins, held OK. Drilled out with 8 3/4" bit.
