Total 39 holes. Treated new perfs w/2500 gal 7.5% HCL & 57 perf balls. On 1/13/12, fraced w/48,835# 16/30 Brady & 6,757# 16/30 siber prop sand in X-linked gel. CO after frac to CBP @ 3180'. Land 2-7/8" tbq @ 2815' & ran pump & rods. Release workover rig on 1/19/12. We plan to pump test lower San Andres perfs 2890'-3080' for about 2 weeks before continuing with the workover procedure.

Existing Glorieta/Yeso perfs are @ 3363'-3503' w/97 holes.
