Total 55 holes. Treated new perfs w/2500 gal 7.5% HCL & 83 perf balls. On 2/2/12, fraced w/68,319# 16/30 Brady & 26,680# 16/30 siber prop sand in X-linked gel. CO after frac, drilled out CBPs @ 2800' & 3180', & CO to CBP @ 3346'. Landed 2-7/8" 6.5# J-55 tbg @ 2850' & ran pump & rods. Release workover rig on 2/7/12. Completed as a single San Andres oil well. We plan to test the San Andres for about 3 weeks, and then commingle with the existing Yeso perfs (3363'-3503') as per DHC-4483.
