Randy, please see attached for a copy of the C-104 requesting a temporary allowable for our Smokey Bits State Com #3H, API No. 30-015-39118. We are currently pumping this well to get the load back and on 3/22/12 started receiving oil, and have produced almost 10000 bbls of oil. We currently have 24 frac tanks on location for the production. The plan is to finish pumping back the load when the frac tanks are full, shut-in the well and start facility construction and also due to environmental concerns we would like to sell the oil that is currently on location. I am currently working on the final completion reports and they should be filed by the first of next week. The latest test for this well was on Tuesday 4/3/12 for 790BO 590BW 1071MCFD on a ESP. .
