LRE Operating would like to open the San Andres in this existing Yeso oil well as follows:

TOH w/rods, pump, & tbg. Set a 5-1/2" CBP above the existing Yeso perms (3341'-3499') @ about 3300'. PT 5-1/2" csg to 500-1000 psi. Perf San Andres @ about 2805'-3240'. Break down the new San Andres perms w/about 5000 gal 15% NEFE acid & frac w/about 150,000# 16/30 & 60,000# 12/20 sand in 25# X-linked gel. Clean out after frac. Run production tbg, pump & rods & initiate pumping San Andres only. The existing Yeso perms will remain shut-in below the RBP. We may apply for a commingle order in the future.
