RU pump and established rate down 8-5/8" casing, 1 BPM @ 400 psi. Squeezed 200 sx C cmt down 8-5/8" casing, ISIP 50 psi. SDFN, will tag in am.**

**Opened well, static. RIH w/ wireline, tagged cmt @ 13'. POOH w/ wireline, RD coiled tubing unit. ND wellhead, pumped 10 sx C cmt 13' to surface. RDMO.**

**04/04/05 Monday**

**Cut off wellhead & anchors, capped well, installed dry hole marker. Backfilled cellar, covered existing pit, cleaned location. Approved as to plugging of the well bore. Liability under bond is retained until surface restoration is completed.**
