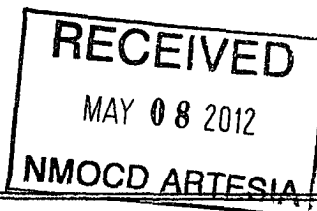

Spudded well on 4/9/12 w/12-1/4" bit. Drilled 12-1/4" hole to 405'. Set 8-5/8" 24# J-55 csg @ 397'. Cmted w/375 sx (503 cf) "C" cmt w/2% Cacl2 & 1/8# cello flake. Circ 170 sx cmt to pit. On 4/11/12, pressure tested 8-5/8" csg to 1000 psi for 30 min - OK.

Drilled 7-7/8" hole to TD4915' on 4/18/12. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4897'. Cmted lead w/340 sx (646 cf) 35/65 poz "C" cmt w/5% salt, 5# LCM-1, 0.06% R-3, & 0.125# CF & tailed w/525 sx (693 cf) cl "C" cmt w/0.6% R-3 & 1/8# CF. Circ 3 sx cmt to surface. Released drilling rig on 4/19/12. Plan to pressure test 5-1/2" csg before completion operations.
