Spud well on 5/2/12. Drilled 12-1/4" hole to 490'. Landed 8-5/8" 24# J-55 csg @ 480'. Cmted w/300 sx (405 cf) "C" cmt w/2% CaCl2 & 0.25# CF. Circ 116 sx cmt to surface. On 5/3/12, PT 8-5/8" csg to 800 psi for 30 min-OK.

Drilled 7-7/8" hole from 8-5/8" csg shoe to 5000' on 5/8/12. Ran open hole logs. On 5/9/12, landed 5-1/2" 17# J-55 csg @ 4977'. Cmted lead w/350 sx (665 cf) 35/65 poz "C" cmt w/1/8#/sx CF, 5% salt, 5# LCM-1 & 0.06% R-3. Tailed w/550 sx (726 cf) "C" cmt w/0.125#/sx CF & 0.06% R-3. Circ 59 sx cmt to pit. Released drilling rig on 5/10/12. Plan to pressure test the 5-1/2" csg before completion operations.
