Frac new perfs w/ 1000 gals 15% HCL, 24300 gals 20# XL gel and 38480# 20/40 SLC Sand. Flow/swab well back. TOOH. RIH bit and clean down to 5380'. TOOH w/ bit. RIH w/ 2-7/8" tbg and rods. Place well on production.
