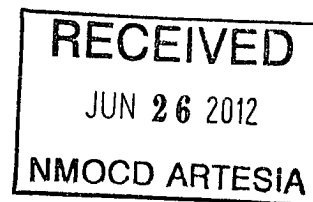

Tailed in with 200 sx Class "C" + 1% CaCl (yld 1.33, wt 14.8). Circulated 96 sx to surface. Tested casing to 1500 psi for 30 min, good. WOC 27 hrs. Reduced hole to 8-3/4" and resumed drilling.
