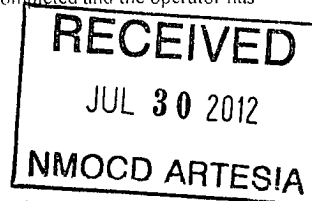

13. Describe Proposed or Completed Operation. Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. 1. RIH with 1" pipe to bottom of casing.
2. Pump Class "C" Cement until full returns to surface
3. POOH with 1" and wait 15 minutes and monitor well for fall back.
4. Top out well with cement
5. Install 4" P & A marker per BLM requirements.



*Tag bottom, circulate cement to surface,
@ cut-off 1" cement to surface all annulus.*
