Cemented with 760 sx Class "C" + 0.125#/sx D130 + 3% D020 + 0.2% D046 + 0.1% D065 + 0.5% S001 (yld 1.71, wt 13.5). Circulated 325 sx to pit. Tested casing to 1200 psi for 30 min, held good. WOC 39 hrs 30 min. Reduced hole to 12-1/4" and resumed drilling.
