BOPCO, L.P. requests a variance to utilize a 10", 230 psi WP hose for the flowline line under the rig substructure in replace of the steel flowline from the rotating head to the flowline manifold. Utilizing this hose will quicken nipple up times during rig skidding operations and reduce safety issues associated with welding on the flowline during BOP NU. The hose itself is rated to 230 psi WP and has 150# flanges on each end rated to 230 psi WP. This hose matches the rated working pressure of the flowline system on the rig.

The pressure test certification from the hose manufacturer is attached along with a picture of the hose. This is the only pressure test documentation available for the hose.
