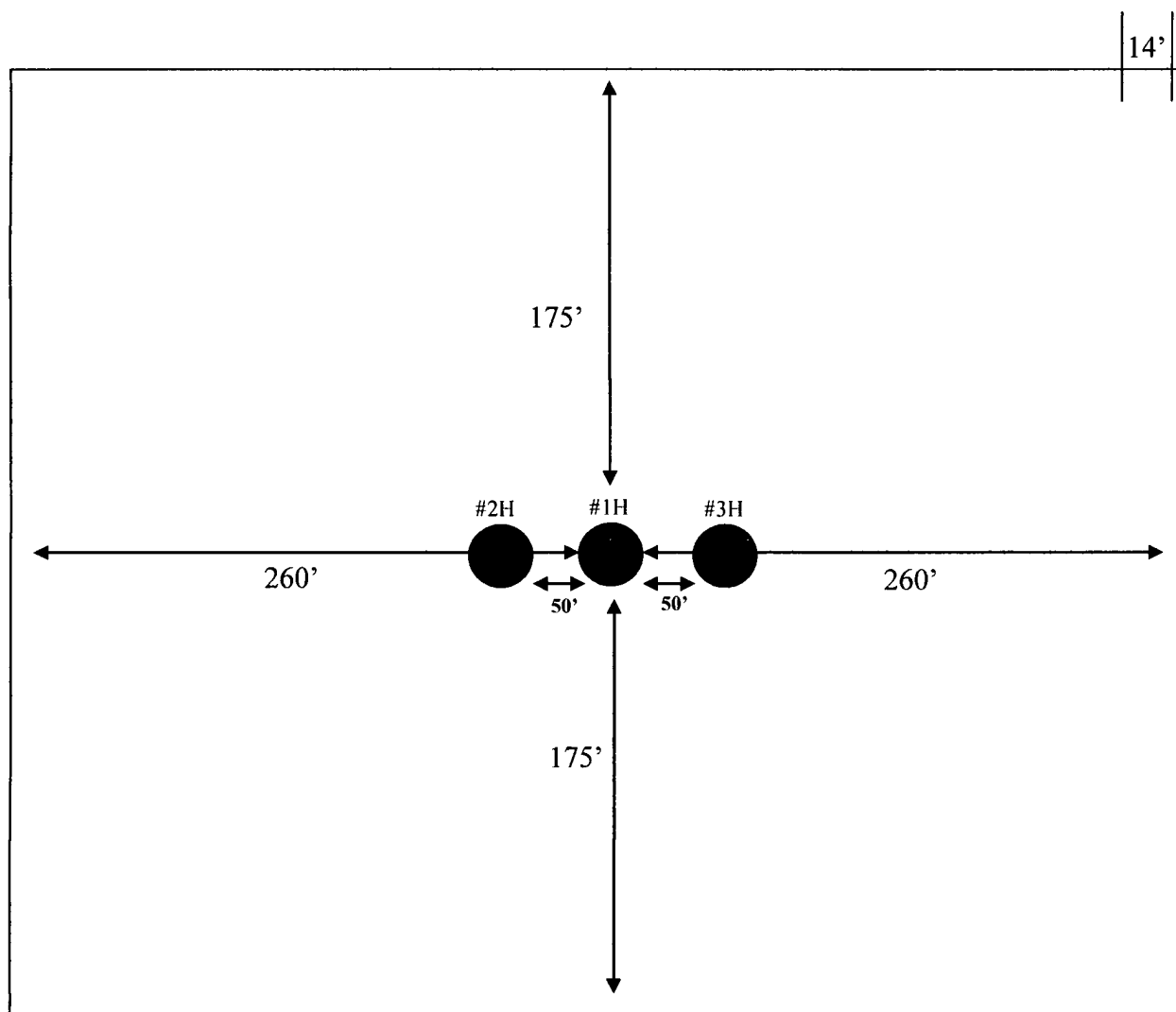

V-DOOR EAST



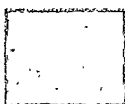

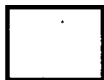
