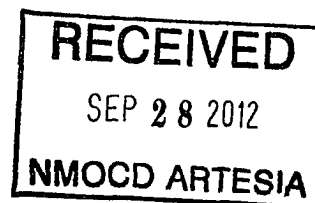

The spacing for said line will be 30 feet wide by 405.04 feet (24.55 rods), consisting of 0.279 acres.

These lines will carry 1 MMCFD, 100 BOPD, and 500 BWPD at 100 psi.

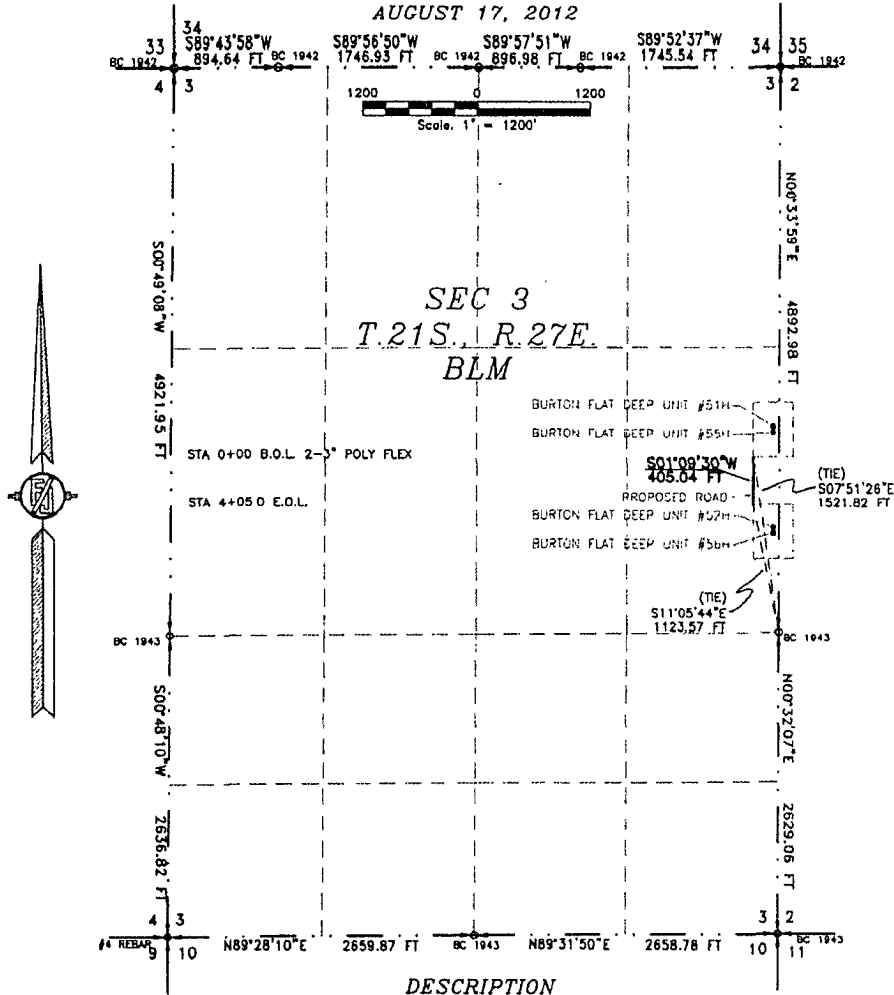

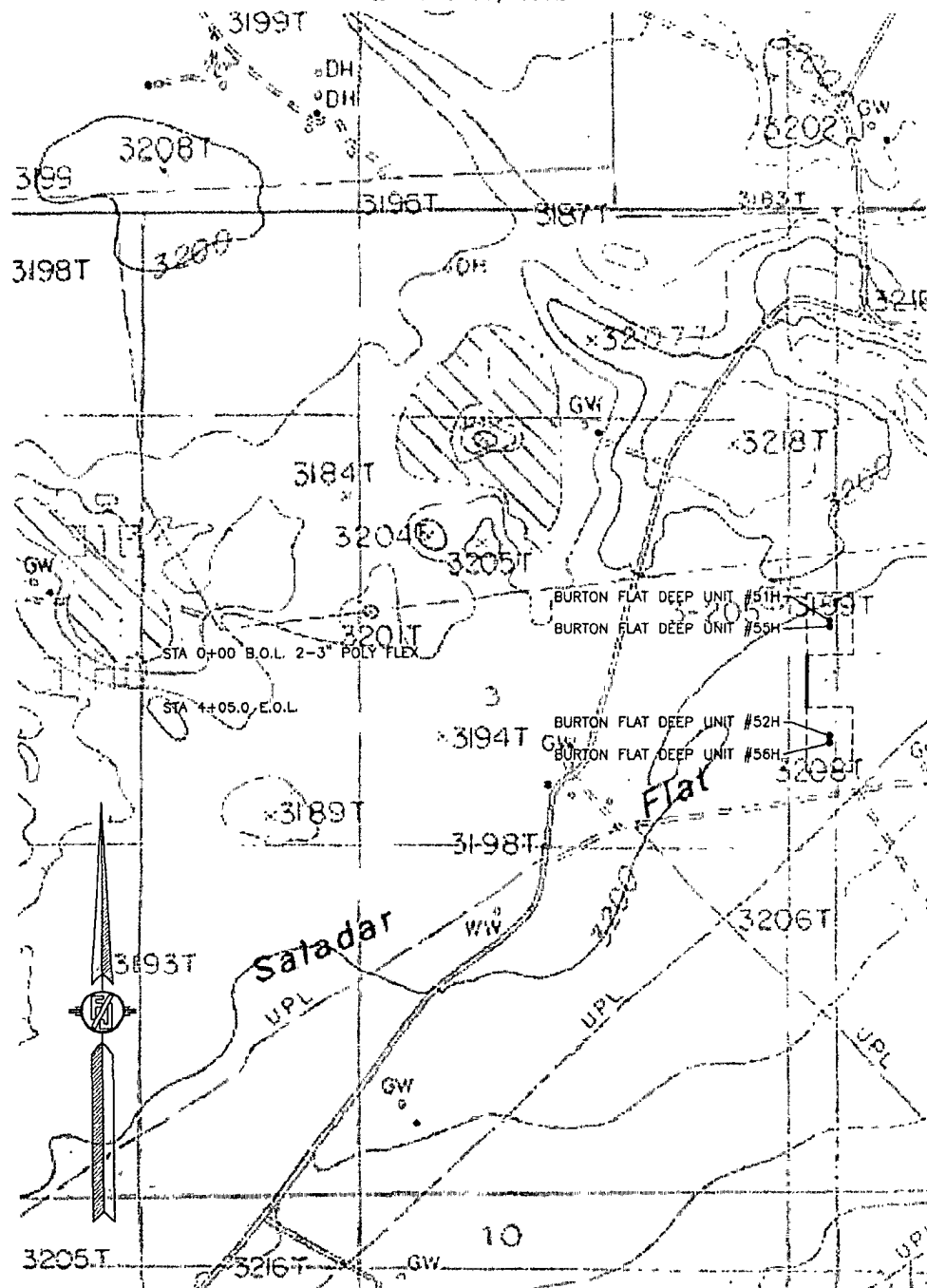

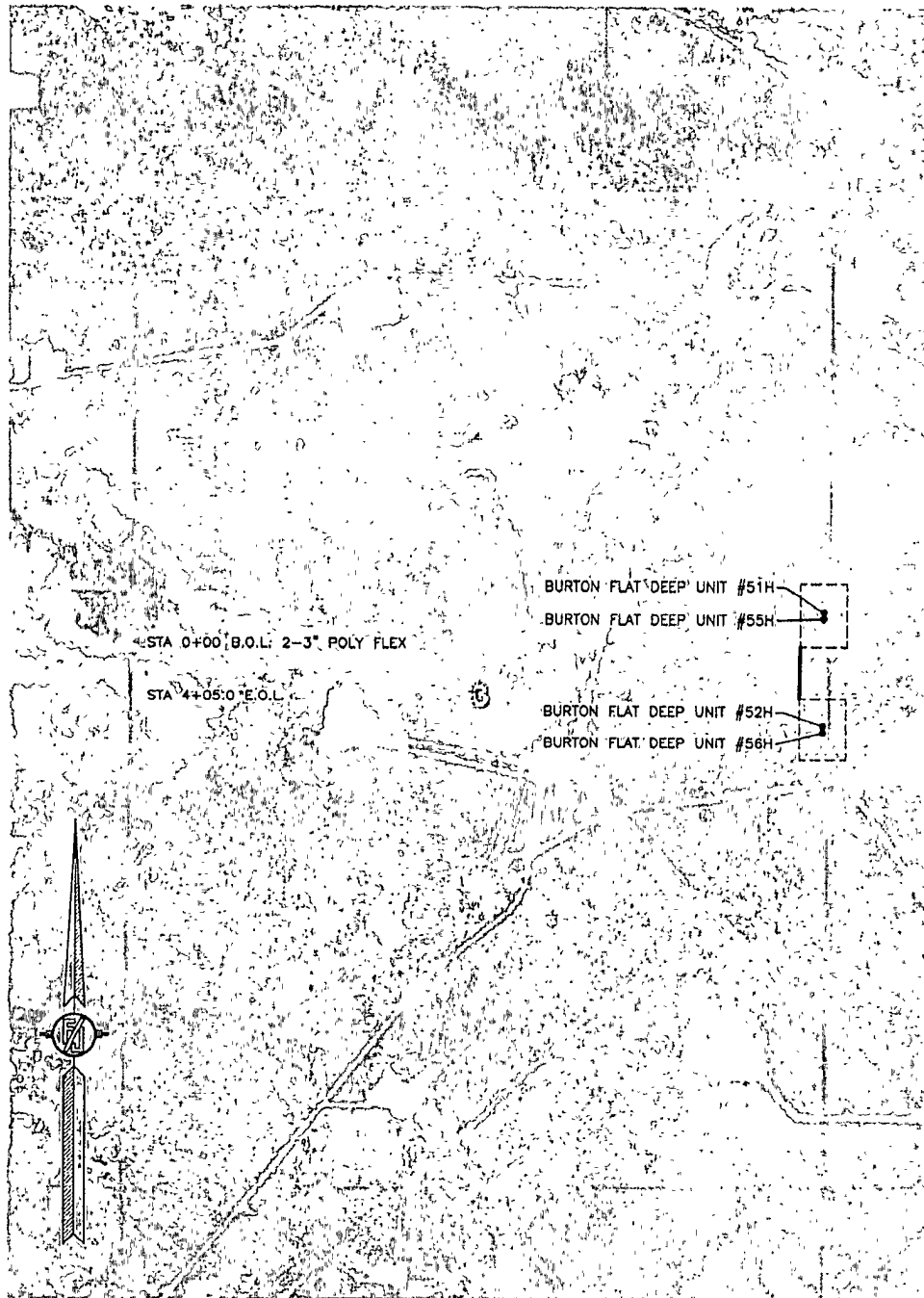
