Tagged TOC at 7303' Pressure tested 7" casing from surface to 7470' to 540 psi for 30 min on a chart. Lost 25 psi in 30 min, looked good. 8/20/12 - Circulated hole with 2% KCL. Perforated Bone Spring 5600'-5578'(30) 8/21/12 - Spotted 5 bbls 20% HCL acid across perfs. Pressure tested casing to 1000 psi. Acidized with 3000g gelled 20% HCL NEFE acid. Dropped 45 balls during job, had ball action but no ball out. Overflushed well with 20 bbls. 8/26/12 - ND BOP. CST packer and 2-7/8" 6.5# L-80 tubing at 5480'.
