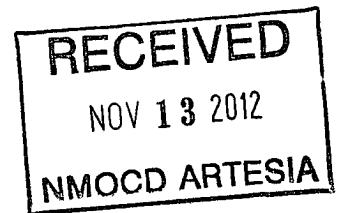
10/10/12 TD 12 1/4" hole. Ran 1430' of 9 5/8" 36# J55 LT&C csg. Cemented with 300 sks EconoCem-HLC w/additives. Mixed @ 12.5 #/g w/2.11 yd. Tail w/200 sks HalCem-C neat. Mixed @ 14.8#/g w/1.33 yd. Plug down @ 7:00 P.M. 10/10/12. Circulated 55 sks of cement to the pit. At 7:30 PM 10/11/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
