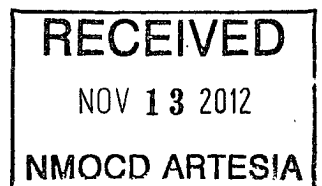

Plug down @ 6:15 P.M. 10/28/12. Circulated 115 sks of cement to the pit. At 12:45 PM 10/29/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 6 1/8" bit.
