3. If well produces 1 BBL of oil per day, well will considered productive with casing tests to follow within 15 days.
4. If casing leak is encountered, appropriate measures to repair casing will be done within 30 days of casing leak test.
5. If well is to be plugged Operator will supply BLM CFO a proposed plugging procedure for approval.
6. Plugging operation will begin within 15 days of return of approved submittal.
