 3/4-6/05 Re-acidize with 3200g 20% IC acid and 125 balls.
 3/7/05 Set 5-1/2" composite plug at 5700'. Perforate Strawn 5362'-5376' (56), 5448'-5454' (14), 5508'-5516' (18) and 5532'-5542' (40).
 3/8/05 Acidize Strawn with 2000g 7-1/2% IC acid with 192 ball sealers.
 3/10/05 Drilled composite plug at 5700'. Drilled composite plug and pushed down to 5800'. Set packer at 5133'.
 3/12/05 Frac Strawn and Silurian with 40# Medallion Binary frac with 778 bbls fluid, 151 tons CO2, 3800# 100 mesh, 155100# 20/40 White sand.


