Yates Petroleum Corporation plans to plug and abandon this well as follows: Rig up safety equipment as needed. POOH with tubing. Set a 7" CIBP at 2170' with 35' cement on top. Circulate plugging mud on top of CIBP. Pull tubing up to 1260' and spot 35 sx cement surface shoe plug. Tag plug. Pull tubing up to 60' and circulate cement to surface. Tag plug. Install dry hole marker and clean up location as per regulated.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits
