Yates Petroleum Corporation plans to plugback and recomplete this well as follows: Set a CIBP at 8916' and cap with 35' cement on top. (Load and test casing to 1000 psi, if no test is achieved locate and fix hole) Perforate squeeze hole at +/-3940'. Re-cement with 250 sx "C" with additives, bring TOC to +/-2600'. Perforate Abo 3960'-4014' (55), 4104'-4144' (41) and 4206'-4252' (47) for a total of 143 holes. Stimulate as needed.
