05-29-05 In 12-1/4" hole, ran 36 jts 9-5/8" 40# N-80 8rd LT&C New Inspected/New casing to 1572'. Cemented lead with 925 sx Interfill C + 1/4# Flocele and tail 200 sx Premium Plus + 2% CaCl. Circulated 97 sx to surface. WOC 20.5 hours.
