6/3/05 - Set 13-3/8" 48# H-40 ST&C casing at 382'. Cemented with 180 sx "H" + 10% A-10 + 1/4# Celloflake + 10# LCM-1 + 1% CaCl2 (yld 1.52, wt 14.6). Tailed in with 450 sx "C" + 2% CaCl2 + 1/4# Celloflake (yld 1.34, wt 14.8). Cement circulated to surface. WOC. Tested casing to 600 psi for 30 min. WOC 21 hrs 15 min. Reduced hole to 12-1/4" and resumed drilling.
6/9/05 - Set 9-5/8" 36# J-55 ST&C casing at 1960'. Cemented with 450 sx 35:65:6 "C" + 5% Salt + 1/4# Celloflake + 5# LCM-1 (yld 2.05, wt 12.5). Tailed in with 200 sx "C" cement. Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 32 hrs 30 min. Reduced hole to 8-3/4" and resumed drilling.
