Circulated 103 sxs. Circulated thru D.V. Tool for 4 hrs. Stage 2: 600 sxs BJ Lite + 1/4# Celloflake + 5# salt. (yld 1.95, wt 12.5)

Tailed in with 500 sxs Super "C" Modified + 3# LCM1 + .5% FL52 + .3% FL25 (yld 1.64, wt 13.2). Plug down 11:00 PM, 4/14/2005.

Bumped plug to 2800 psi for 10 min.
