WOC 36 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 11" hole to 2490' and 7-7/8" hole to 7490'. Ran 150 jts 5-1/2" 15.5#, J-55, LTC & 32 jts 5-1/2", 17#, J-55 LTC casing set @ 7488'. Cement with 720 sx Premium Plus + 2% Zone Seal 2000 w/Nitrogen. TOC by Temp Survey 3410'. Release Rig @ 6:00 p.m. 8/11/05. Prep for completion.
