BJ Services pumped 180 sks Class C cement w/10% Thixotropic mix then 450 sks "C" W/2% CaCl. Cement did circulate to surface. Notified BLM of cement time. BLM did show. WOC required 18 hours. NU hydril, GIH w/bit & drill pipe, Test all to 1000 psi for 15 mins-held ok.

5/26-27/05 Run total of 123 jts (5367') 7" 23# J55 New R3 LT&C csg(75 JTS W/RYTWRAP CTG), FS @ 5368', FC @ 5325', DV T @ 2618'. Total of 20 centralizers. BJ Services cemented w/total 1800 sks Class "C" & Poz w/additives & 250 sks Cl "C" in two stages. Plug down 11:50 AM 5/27/05. BLM's Don Cleghorn notified of planned cement time. BLM no show.

6/02-07/05 Drill out DV tool, test casing to 1000 psi for 15 mins- held ok. PBTD 5325'. Perf 4552'-4793', total 26 holes @ 2SPF. Acidize w/2000 gals 15% FE. Treat perfs w/ 34,285 gals 20% Hot HCL, 57,073 gals WFG-R, 4787 gals 15% HCL acid.

Run 2 7/8" tbg & rods. Install flowline to existing Gissler B3 Battery. Install pumping unit, turn well to battery.
