Set 4-1/2" CIBP at 3650' w/35' cement on top. Circulate hole w/245 bbls mud laden fluid. Hole in 4-1/2" casing came up 8-5/8" casing as well. Set 4-1/2" AD-1 packer at 1302'. Isolate hole in casing at 1576. PUH to 1302'. Perforate at 1600', squeeze w/50 sx Class "C" Neat cement. WOC 4 hrs. No tag. Squeeze w/50 sx Class "C" Neat cement. Close well in w/800 psi. WOC. Tag plug at 1497'. POOH with packer. Perforate 4-1/2" casing at 1000'. Set 4-1/2" AD-1 packer at 683', squeeze with 50 sx Class "C" Neat cement. Close well in w/0 psi. WOC 4 hrs. No tag. Re-squeeze with 50 sx Class "C" Neat cement. Close well in w/500 psi. WOC. Release packer. Tag plug at 894'. Perforate 4-1/2" casing at 100'. Circulate 70 sx Class "C" Neat cement down 4-1/2" casing and up to surface of 10-3/4" casing. Close well in w/1000 psi. WOC 3 hrs. Cement at surface. Cut off wellhead. Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
