Yates Petroleum Corporation respectfully requests a variance to test the 2000psi BOP to 1200psi using rig pumps. The maximum anticipated surface pressure at a total depth of 4850' should not reach 1200psi.

It is also requested that flow sensors and pit volume totalizer not be used due to the change in TD to 4850'. This is an Abo test and the Wolfcamp is being cut only to ensure being through the Abo.
