Yates Petroleum Corporation respectfully requests permission to temporarily abandon this well in order to fully evaluate it for the waterflood area. The estimated date of production will be approximately 5 years.

Temporarily abandonment procedures are as follows:

1. MIRU a WSU. RU safety trailer as necessary & TOH w/ production equipment. ND WH, NU BOP. TOH w/ tbg.
2. RIH w/ gauge ring & then RIH w/ tbg & 4 1/2" CIBP set at 1,326'.
3. Circulate hole w/ corrosion inhibited fluid.
4. Shut BOP & test csg to 500 psi for 30 min (10% leak off allowed). Chart test & report.
5. TOH laying down tbg.
6. Notify OCD & BLM 24 hrs prior to conducting MIT. Chart test.
7. Clean up location & release equipment.

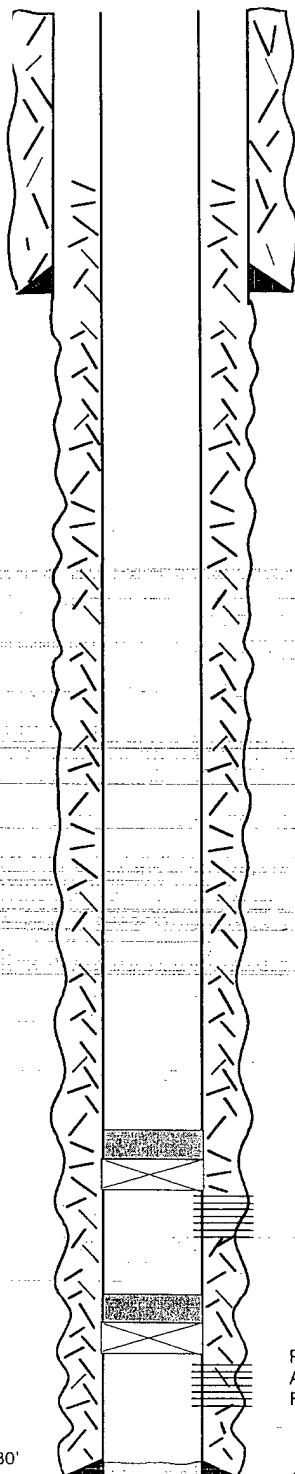

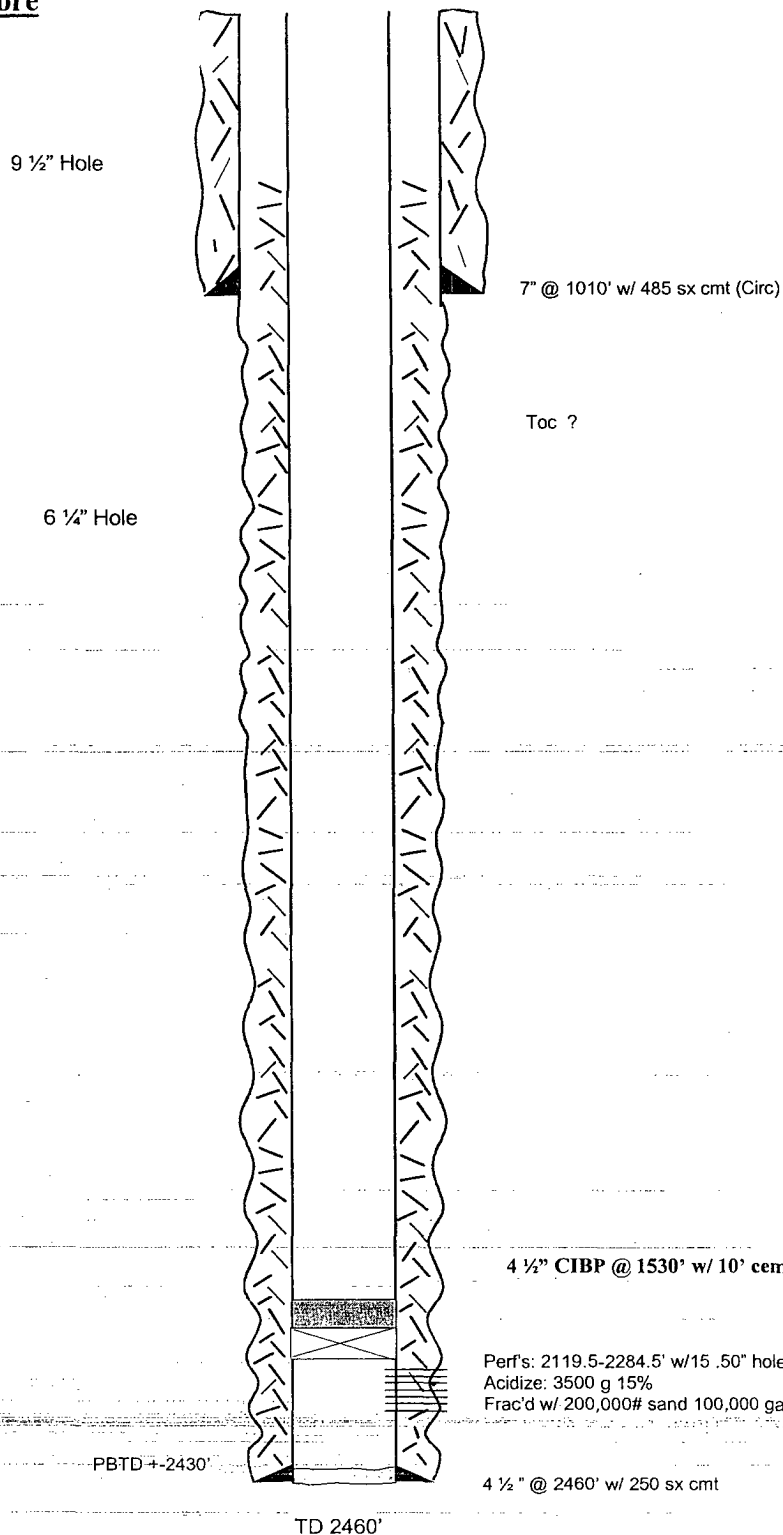
