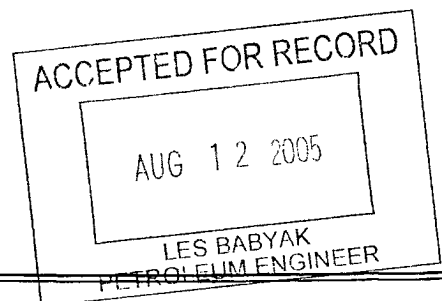

07-28-05 Ran 80 jts 9-5/8" 40# J-55 LTC casing to 3200'. Cemented with lead of 750sx Interfill C + 1/4# Flocele and tail of 200sx Premium Plus + 1% CaCl. Circulated 185sx to pit. WOC 13.25 hours. Tested casing to 1500psi.
