7/15/05 Frac Abo 3968'-3990' with 125,000g 33Q CO2 foam and 250K 16/30. Wellhead started leaking around 5-1/2" casing, could have a hole in casing.

7/18/05 Set RBP at 2600' (TOC). Tested 5-1/2" casing from 130' down to 2600', held OK. At 120' up to surface would not test. Casing head nut and pack off assembly cut out and damaged.

7/19/05 Back off casing at 213'. Pulled 5 joints of 5-1/2" 14# K-55 casing. 1st and 2nd joints had holes. Ran 5 joints of 5-1/2" 15.5# J-55. Screw casing back together and test to 2500# for 30 min, OK. Released RBP.

7/21/05 Perforate Abo 3782'-3788', 3796'-3804', 3810'-3814', 3832'-3838', 3850'-3864', 3892'-3894', 3908'-3912' and 3916'-3920' for a total of 56 holes.

7/25/05 Spotted 2000g 7-1/2% IC acid.

7/26/05 Frac Abo 3782'-3920' with 114,000g 33Q CO2 foam and 300,000# 20/40.
