8/9/05 Set composite BP at 4600'. Perforate Abo 3962'-3970', 3998'-4004', 4092'-4100', 4118'-4126', 4160'-4172', 4198'-4200', 4203'-4208', 4234'-4242', 4258'-4262' and 4320'-4328' with a total of 79 holes.

8/10/05 Spotted 2500g 7-1/2% IC acid.

8/11/05 Frac Abo with 125,000g 33Q CO2 foam and 250K 20/40 Brown. ASI 10K packer with 2.25" on/off tool at 3914'.


