Yates Petroleum Corporation plans to return this well to producing status as follows: MIRU all safety equipment. Test casing with 2% KCl water. Pressure test casing to 500 psi. If casing fails pressure test, look for holes and report results. Drill out CIBP at 7546' and cement to 7788' with 4-1/2" bit collars and 2-7/8" tubing. Circulate hole clean. Set 5-1/2" packer and 2-7/8" tubing at +/-7546'. Stimulate as needed. Swab test and evaluate reporting results. POH with packer and tubing. TIH with sub pump and turn over to production.


