Devon Energy Production Company, LP, respectfully requests approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake-Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas.

This pool was pre-approved by Division order PC-1108.

The San Andres is perforated at 1934-2408' and the Yeso is perforated from 2986-3290'.

Average production from the SA is 10.9 oil and 76.5 gas. Average production from the Yeso is 13.8 oil and 33.5 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 55.9% and gas is 30.4%.

For the San Andres formation, oil is 44.1% and gas is 69.6%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.

The BLM has been notified of this filing.
