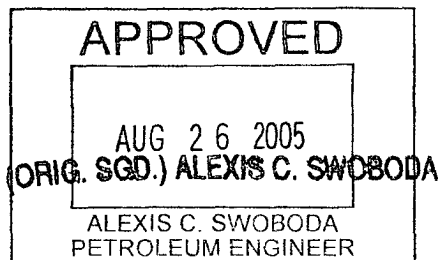

Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres 51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 1816-2744' and the Yeso is perforated from 2874-3394'. Average production from the SA is 22.6 oil and 101.9 gas. Average production from the Yeso is 7.6 oil and 21.2 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 25.2% and gas is 17.2%. For the San Andres formation, oil is 74.8% and gas is 82.8%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
