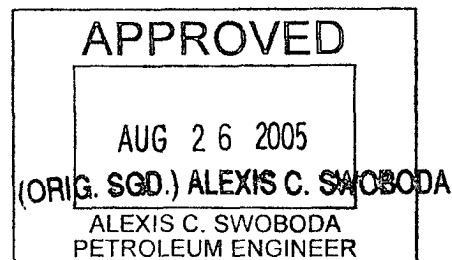

Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 1902-2380' and the Yeso is perforated from 2875-3275'. Average production from the SA is 5.9 oil and 29.7 gas. Average production from the Yeso is 3.6 oil and 20.5 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 37.9% and gas is 40.8%. For the San Andres formation, oil is 62.1% and gas is 59.2%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
