Dear Ms. Truesdell:

Reference is made to the following: (i) your application (*administrative application reference No. pSEM0-521745808*) filed on behalf of the operator Edge Petroleum Operating Company, Inc. ("Edge") with the New Mexico Oil Conservation Division ("Division") in Santa Fe, New Mexico on August 5, 2005; (ii) your telephone conversation with Mr. Michael E. Stogner, Engineer with the Division in Santa Fe on Thursday morning, August 18, 2005; and (iii) the Division's records in Santa Fe, including the file on Division Administrative Order NSL-5028: all concerning Edge's request for a non-standard deep gas well location to be applicable to any and all formations and/or pools from the top of the Wolfcamp to the base of the Morrow formation that are:

- (1) developed on 320-acre spacing; and
- (2) governed under the provisions of either Division Rule 104.C (2), which presently includes but not necessarily limited to the Box Canyon-Permo Pennsylvanian Gas Pool (72780), Undesignated Box Canyon-Strawn Gas Pool (72890), and Little Box Canyon-Morrow Gas Pool (90240).

The S/2 of Section 13, Township 21 South, Range 21 East, NMPM, Eddy County, New Mexico is to be dedicated to this well in order to form a standard 320-acre lay-down deep gas spacing unit.

This application has been duly filed under the provisions of Division Rules 104.F and 1207.A (2).


